Notice concerning candidates for Directors and Executive Officers of Dentsu Group Inc.

Dentsu Group Inc. (Tokyo: 4324; ISIN: JP3551520004; President & Global CEO: Hiroshi Igarashi; Head Office: Tokyo; Capital: 74,609.81 million yen; hereinafter referred to as "the Company") announced that at the Board of Directors meeting held today, the following candidates for directors were informally nominated to be recommended to the Company's 176th Ordinary General Meeting of Shareholders scheduled to be held on March 28, 2025, and candidates for executive officers to be appointed at the Board of Directors meeting to be held after the Ordinary General Meeting of Shareholders.

By appointing the following directors and executive officers (which is subject to approval at the ordinary general meeting of shareholders), the Company will work to further strengthen its supervisory and execution functions. Going forward, the Company will continue to maximize corporate value for all of its stakeholders, including shareholders, clients, partners, and employees, and will more strongly promote the realization of medium- to long-term value creation for society as a whole.

Regarding candidates for directors

As the terms of office of the current 9 directors of the Company will expire at the conclusion of the 176th Ordinary General Meeting of Shareholders, 11 candidates for the position of director will be recommended to the Ordinary General Meeting of Shareholders.

Regarding the composition of the 11 candidates, in addition to further strengthening corporate governance by increasing the composition ratio of independent outside directors (82%), increasing the number of non-executive directors (2 executive, 9 non-executive), and appointing an independent outside director as chairman of the board of directors, the Company also has a balanced composition of the Board of Directors (2 foreign nationals and 3 females).

The company will recommend three candidates for new independent outside directors: Mr. Yoshihiko Kawamura, who has experience in promoting the globalization of Japanese companies from a business and management perspective and leading structural reform as CFO; Mr. Norimitsu Takashima, who has served as Vice-Minister of Justice and Chief Prosecutor of the Nagoya High Public Prosecutors Office; and Ms. Naoko Ichikawa, who has a track record at consulting firms and business companies and has a wide range of global expertise.
