## **Dentsu Establishes the DENTSU SOKEN Center of Economic Security Research (DCER)**

**– Integrating dentsu’s intelligence and technology to provide multifaceted support for businesses' economic and cyber security –**

Born in Tokyo. Graduated from the Faculty of Law at the University of Tokyo and joined the National Police Agency in 1980. Has held various positions, including Executive Secretary to the Prime Minister, Director of Cabinet Intelligence and Secretary General of National Security Secretariat/National Security Advisor to the Cabinet. He established the Economic Section within the secretariat and promoted economic security policies. In December 2020, Kitamura was awarded the Defense Department Distinguished Service Medal by the US government. After retiring from governmental duties in July 2021, he became a member of the expert committee on economic security legislation in November of the same year. Kitamura is also the President & CEO of Kitamura Economic Security Inc.
