Notice concerning candidates for Directors of Dentsu Group Inc.

Dentsu Group Inc. (Tokyo: 4324; ISIN: JP3551520004; Director, Representative Executive Officer, President & Global CEO: Hiroshi Igarashi; Head Office: Tokyo; Capital: 74,609.81 million yen; hereinafter referred to as "the Company") announced that at the Board of Directors meeting held today, the following candidates for directors were informally nominated to be recommended to the Company's 175th Ordinary General Meeting of Shareholders scheduled to be held on March 28, 2024.

As the terms of office of current 9 directors of the Company will expire at the conclusion of the 175th Ordinary General Meeting of Shareholders, 9 candidates for the position of director will be recommended to the Ordinary General Meeting of Shareholders.

Regarding the composition of the 9 directors, in addition to recommending a majority of 6 Independent Outside Directors (67%), the Company has balanced the diversity of the Board of Directors (3 foreign nationals and 2 females) and the number of members for business execution and supervisory functions (2 executive and 7 non-executive) appropriately.

By appointing the following directors (which is subject to approval at the ordinary general meeting of shareholders) and by operating under a system of a Company with Three Committees, the Company will also work to further strengthen its supervisory functions with a diverse Group Management Team to drive execution. Going forward, dentsu, as B2B2S (Business to Business to Society) group, will continue to maximize corporate value for all of its stakeholders, including shareholders, clients, partners, and employees, and will more strongly promote the realization of medium- to long-term value creation for society as a whole.
